ORAL HEALTH FOR 0-17 YEARS

General Practice Staff can

- improve awareness of effective oral health care
- encourage the uptake of free oral health care

Key messages to promote are:

1. Brush teeth twice a day with fluoride toothpaste
2. Have regular dental check-ups
3. Lift the lip every month and check your child's teeth and gums
4. Choose healthy snacks
5. Drink water and milk



Children in New Zealand are entitled to free basic oral health services until their 18th birthday.

Parents and caregivers can enrol their children after they turn 12-months of age with the Canterbury DHB Community Dental Service. A registration form is in the Oral Health Information for 0-5 year olds folder.

Primary and Intermediate School children will be seen at school by the Community Dental Service

Adolescents in year 9 (at high school) need to enrol with a contracted dentist. The General Practice Adolescent Oral Health Information folder has a list of contracted dentists and information on how to enrol.

Community Law Canterbury is a Community Law Centre.

Community Law Centres are non profit organisations which work to reduce and remove barriers to the law. Community Law Canterbury's services provide quality, free legal help to people in Canterbury who face barriers in accessing justice.

Free Legal Information

The law centre operates a telephone legal information service which is staffed by volunteer senior law students or graduates and Community Law Canterbury staff. This service offers basic legal information on the area of law in question or an appropriate referral is made to our advice service, a solicitor or other agency.

Community Law Canterbury offers a general legal advice service as well as specialist advice and information services. We do not give advice over the phone and do not advise in commercial matters or give advice to landlords or employers. We have the following advice services:

General Legal Advice

The law centre operates a drop in free legal advice service which is staffed by volunteer solicitors, senior law students and graduates. The graduate or student volunteer will interview clients privately and then consult with the solicitor on duty to obtain the appropriate advice. Where ongoing help is needed and there is an unmet legal need, staff solicitors can provide assistance including a limited amount of Court/Tribunal representation.

Employment Advice

A specialist advice and information service for people with problems relating to employment law. This service operates every Wednesday evening by appointment.

Resource Management Service

A specialist advice service for people and groups with problems relating to the Resource Management Act 1991 and other areas of planning law. This service operates by appointment. Appointments can be made by phoning reception on 03 366 6870

Legal Education Course

We offer an eight week 3 hour education course aimed at community workers. Maori Health

Traditional Healing

Te Rapana Trust is a charitable trust established in December 2000 to promote and organise Rongoa Maori Services in Te Waipounamu initially within its Christchurch based clinic Nga Rau Rakau o te Ora.

In 1907 parliament passed the Tohunga Suppression Act, the affects of which were severe on Rongoa Practitioners for they were no longer recognised by the government or western institutions for their knowledge or relevance to Maori social, economic, cultural and environmental initiatives.

Fortunately, in the late 1990s Ministry of Health officials and a national association of Maori traditional healers called Nga Ringawhakahaere worked together to produce national guidelines and standards of practice to obtain government support for Rongoa Maori Services in Aotearoa. This work was an appropriate acknowledgment of the importance of matauranga Māori as it pertains to Rongoa.

In 2000 He Oranga Pounamu approached Heeni Phillips to deliver its Rongoa Maori Services contract. Although reluctant, Heeni agreed and identified Connie Hassan and Maire Kipa as interim trustees. Their role has been to govern the strategic and business planning processes for the clinic and Te Rapana Trust. Since then three new trustees have accepted appointments. They are: Karen Mills (no Ngati Porou), Mamatere Strickland (no Nga Puhi) and Dr Murray Parsons (no Ngati Kahungungu).

Rongoa

Rongoa is the practice of extracting the healing properties of leaves, twigs and bark from native trees and plants of Aotearoa. It can be dispensed in liquid, ointment or capsule form.

Mission Statement

To provide holistic healing through traditional Rongoa Maori Services in Christchurch and Te Waipounamu, upholding tikanga Maori, promoting quality and excellence to benefit whanau spiritual, physical, mental and socio-cultural needs by a support network of Tohunga and locally based Kaiarahi and Kaiawhina.

Nga Rau Rakau o te Ora

Nga Rau Rakau o te Ora is the Trusts Whare Rongoa or Rongoa Clinic run by Heeni Phillips.

The whare is used mainly by Maori but also has Pacific Island and Pakeha whanau who regularly visit. Whanau have come to understand that since Heeni's home has been the base for rongoa services since 1988, it is a place that embraces the holistic approach to whanau physical, emotional, cultural and spiritual well-being. It also offers some respite care for those needing extra special care.

Funding has helped to improve facilities and two full-time staff are employed to assist Heeni to uphold the tikanga of Whakawhanaungatanga and the gathering and processing nga rau for rongoa. They maintain the kaupapa of Rongoa Maori by not accepting a wage or fee.

Heeni acknowledges the late Rapana Hemi as a Tohunga and mentor since 1984. The name of Te Rapana Trust is important and rightly acknowledges Rapana Hemi as a man of deep and solid knowledge about nga Rongoa Maori, Moe mai I to moenga roa.

Heeni Phillips

(no Rongowhakata, me Ngati Kahungunu, me Rongomaiwahine, me Ruapani, me Ngati Porou) has been a practitioner of Rongoa Maori (Traditional Maori Medicine) since 1984. She has spent 40 years campaigning for te reo Maori and has been a staunch advocate of the kohanga reo movement since 1981.

In December 2000 Heeni established Te Rapana Trust to promote and protect the right of Maori to practice Rongoa. The name pays homage to the late Rapana Hemi, a man of deep knowledge about Nga Rongoa Maori who was her mentor and teacher in the early days. Hohepa Kereopa, a Tuhoe Maori health consultant now provides Heeni with advice and guidance in her work.

Heeni firmly believes that te reo Maori and Rongoa Maori must be revived to benefit Maori now and for future generations.

SMOKING CESSATION IN PREGNANCY PROGRAMME

Our Services

Smokechange pregnancy services to Canterbury families are free personalized support to be smokefree in pregnancy. It is for pregnant women and their partners and is offered to people of all cultures and stages of readiness, in their homes, by phone, email and text. We accept referrals for pregnant women and their partners up to six weeks postpartum.

Our referrers refer to us because they trust in our service. They see first-hand, the extensive detrimental impact to pregnancies from exposure to tobacco, and they see the ripple effect of devastating health consequences for babies and their families.

Our participants work with us because they find us positive and respectful and the programme works to support their change.

Smokefree education for New Zealand midwives is national education to midwives so that they can provide effective support for smoking cessation for pregnant women, and to promote the uptake of smoking cessation programmes by pregnant women.

Our midwives attend our training because they also trust in our education. They, like our referrers (who are predominantly midwives) see first-hand, the extensive detrimental impact to pregnancies from exposure to tobacco, and they see the ripple effect of devastating health consequences for babies and their families.

Our link teams are midwives who link our programme to midwife colleagues and provide peer education. They are passionate about providing their colleagues with the facts, principles and tools to have positive and effective conversations with women about the importance of a smokefree start to life for their baby.

Our kaupapa is "aroha ki te takata".

We are a marae-based provider that works to provide positive alternative services for whaanau, hapuu, and iwi through kaupapa Maaori practice. We offer a bi-cultural holistic hauora service, giving manaaki, awhi and tautoko to ngaa taangata.

To support and empower whaanau who are least resourced in the accordance with the bi-cultural partnership envisaged in Te Tiriti o Waitangi.

To ensure that whaanau wellbeing is the priority focus.

Rehua Marae provides a range of services that empower our people. Our services include whaanau development, marae based support, resources, information, and advocacy. We also provide training in Tikanga Maaori for marae-based workers, and training for whaanau who want to return back into the workforce.

Whaanau ora

A free whaanau ora service is provided by our hauora kaimahi and supported by a registered nurse. This service is for our Taaua and Pooua, Koroua and Kuia aged 55+. The focus is on prevention and management of asthma, diabetes, cardio-vascular, and chronic obstructive respiratory disease.

We also encourage wahine from the age of 40 to participate in breast and cervical screening programmes, and offer support towards positive life changes for wahine regarding menopause.

Kai atawhai tangata

A free service utilised by those aged 55+ with age related disabilities.

Personal care: Our service offers showering / bathing, oral care, grooming and dressing.

Household management

We provide general household duties as required. This does not include lawns or gardens.

Physical Disabilities - Vision and Hearing

Tohu

Our tohu is about the journey one will experience when they come with us to the whare of Maaori Disabilities and Resource Centre.

The Awanui (shell trumpet) on the left symbolises the beginning, as they enter upon a new pathway of wellbeing, support and whaanaungatanga. As one goes through their journey, he or she will become one with our whaanau. Eventually having the strength and support to start a new path. This is demonstrated with the shell on the right.

Whakairo

As you walk up the front path, on the lawn you will see a large beautiful whakairo (lime stone) made from whaanau who have been and are still very much a part of the whaanau.

Whakapapa

In 1986 a movement began, to support and care for our whaanau with disabilities. This Whaanau was known as Ngaati Kaapoo. In 1990 there was a new development, due to vast funding cuts, the impact of which was a name change to Te Whaanau Poouri. In 1991 Te Whaanau Poouri integrated with other disabled groups and this constituted the beginnings of the Maaori Disabilities and Resource Centre – a whaanau way before their time, but still here fighting and supporting the very seed that was planted in the mid 1980s.

In partnership with families we provide a range of individualised, innovative, evidence and strength based services that support the development of positive life skills and outcomes for children and families.

Te Puna Whaiora Glenelg use a resiliency promoting, strengths based approach that provides solution focused, residential and non-residential programmes and mentoring for children aged 5-12 years, one-on-one mentoring for children, and group / individual parent education programmes.

The focus of Te Puna Whaiora Glenelg is to help build resilient children and families. This is achieved through the use of success-oriented activities, health and social skills programmes, educational achievement (Glenelg School attached), and adventure based learning.

Each intervention consists of an assessment, care plan development, short out of home (residential) stay for the child of up to five weeks duration, parent programmes and follow-up. In some cases a non residential mentoring service is provided as well. Residential programmes are held throughout the year.

Health (GP, Specialist, Public Health Nurse) Education (Principal, RTLB GSE) or Social Service professional (Social Worker, Counsellor) can refer children to Glenelg.
